No other applications have been approved for a position on the ballot at this time.



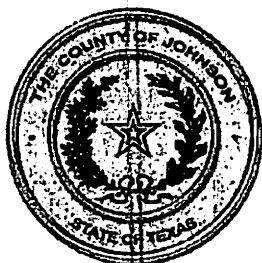
